Refund Policy

This Refund Policy outlines the terms under which refunds will be processed for bookings made through the Chhattisgarh Tourism website (<http://tourism.cgstate.gov.in/>). By making a booking, you agree to this policy.

1. Cancellation & Refund Eligibility

Refunds for cancellations will be processed based on the following conditions:

A. Standard Cancellation Charges

Cancel Before	Charges to be Deducted (In %)
0-48 Hrs of Check-in Date	100%
2-3 Days of Check-in Date	50%
3-7 Days of Check-in Date	25%
7 or More Days of Check-in Date	10%

B. Special Cases for Full Refund

Full refunds will be granted in the following cases:

- Cancellation by Chhattisgarh Tourism Board due to operational or administrative reasons.
- Government orders requiring cancellation of bookings.

2. Refund Processing

- Refunds will be processed through the original payment method used for booking.
- Refunds may take 7-10 working days to reflect in the customer's account, depending on the payment provider.

- Any applicable transaction fees or bank charges will be deducted from the refund amount.

3. Non-Refundable Conditions

- Bookings are non-transferable, and name changes are not permitted.
- If a guest fails to inform the property manager about a late arrival, the booking may be cancelled after 12 hours of the scheduled check-in, with no refund.
- No refund or concession will be provided if the property operates on alternate power sources (solar power) and cannot support air conditioning due to occupancy restrictions.
